



Annual Scholarship Program

2020

I. Summary and Background

Park Side Credit Union has developed an annual scholarship program that awards local high school students who show excellence as unique individuals. The purpose is to recognize innovation and a creative passion for accomplishment, and this scholarship specifically identifies those students who are extraordinary and enthusiastic.

II. Entry Guidelines

A formal application should be submitted by the student and must contain a professional resume, essay component, additional documentation, and the completed entry form (see below). Please email entry packet to marketing@parksidfcu.com or mail a hard copy to the given address by 5pm on Friday, February 28th, 2020.

III. Eligibility

The scholarship program requires that the applicant is a graduating senior at a local high school within Park Side's field of membership that includes eleven counties in western Montana (Flathead, Missoula, Liberty, Toole, Glacier, Lincoln, Lake, Sanders, Mineral, Ravalli, and Beaverhead).

IV. Accomplishments, Community Involvement, & Financial Need

Please include a list of any notable accomplishments, academic honors, and achievement awards as well as a summary of past and current community service or volunteer activities. Optional: please describe your particular circumstances regarding financial need and the impact the scholarship would have upon your situation.

V. Essay

Please submit an essay answering one of the following questions in 250 words or less:

- *How have you proven to be better today than yesterday?*
- *How do you elevate the atmosphere around you?*
- *What are some ways in which you take pleasure in creativity?*
- *How would you make banking fun?*

In addition to this, and within the same document, please include a short paragraph about how you plan to invest the money into your future, if awarded.

VI. Scholarship Details

Park Side Credit Union will award students with a \$1,000 scholarship to be used in pursuing their passion in college/university, trade school, or some form of entrepreneurship. Evaluation will take place immediately following the entry deadline and conclude by March 31st, 2020 – during this time, a committee of Park Side Credit Union employees will review the applications and select the winners. All decisions are final. The scholarship dollars will be awarded by April 30th, 2020.

VII. Selection Criteria

Student applications must contain all of the requested information and will be judged on completeness, accuracy, professionalism, creativity, and vision. Park Side Credit Union reserves the right to select the winners independently without influence.

Important Points to Remember

The student is expected to submit the following to the Park Side Credit Union selection committee:

- Completed application form with signed publicity release
- Professional resume
- Accomplishments, community involvement, and financial need
- Written essay addressing one of the questions above
- Letters of reference (2)

Frequently Asked Questions:

Do I have to use the money for college?

No, the scholarship can be used for any purpose once it is awarded.

Where do I get a reference letter?

Ask a teacher, employer, coach, or mentor for a letter of reference. No letters from family members will be accepted.

What if I am not a member of the credit union?

All local students are eligible for the scholarship. We encourage applicants and winners to join Park Side and open an account but it is not required for consideration.

There isn't a Park Side branch where I live – can I still apply?

If you are already a member, you are automatically eligible. If you currently live in one of the 11 western Montana counties that we serve, you qualify to become a member and can then apply for the scholarship.

How do I know that my application was received?

You should receive an email from Park Side Credit Union within a few days of delivery. Emailing your application is the quickest method.

How will my application be judged?

Every application will be reviewed by the Park Side employee committee and judged on the level of professionalism and creativity. The grading is subjective and is completely up to the selection group.

Why do I have to sign the publicity release?

Park Side Credit Union focuses on community involvement and is active on social media. We would like the ability to use any success stories in our marketing outreach and public relations campaigns.
